# BCV CHOOSING WISELY - STEERING COMMITTEE TERMS OF REFERENCE (DRAFT)

### **ROLE**

The purpose of this group is to implement a programme of work that relates to the 'Choosing Wisely' movement in healthcare. The Choosing Wisely movement supports Western Health's vision to deliver high quality, safe and appropriate patient centred care and management. The initial work of Choosing Wisely at Western Health will focus on Medical Imaging. Work will focus on, but will not be limited to, implementing the six Medical Imaging Guidelines endorsed by the Royal Australian and New Zealand College of Radiologists (RANZCR).

Using a human factors approach the group works to provide leadership, support and guidance in the development, delivery of the implementation of Choosing Wisely recommendations across Western Health. Developing and overseeing the implementation of effective methods for staff engagement and education leading to elimination of unnecessary and sometimes harmful tests, treatments and procedures. This may include the leading and guiding of the implementation activities, the identifying and evaluation of Choosing Wisely performance indicators and initiatives; staff education relating to Choosing Wisely RANZCR recommendations; consumer communication and engagement; and targeted clinical audits of Choosing Wisely RANZCR domains.

#### **OBJECTIVES**

The objective of the BCV Choosing Wisely Committee are to:

- Promote, champion and lead improvement within Choosing Wisely recommendations
- Provide leadership and direction to the activities of the BCV Choosing Wisely at Western Health
- Ensure that any change to systems and processes includes education and tools that can be used after the project ends that will build and sustain the capability of Western Health staff and provide scalability of the Choosing Wisely domains within Western Health.
- Analyse Choosing Wisely related data and prepare reports to assist clinical, support services and other stakeholders to monitor and appropriately manage progress with regard to quality and operational outcomes. This includes monitoring and analysing operational time lost, financial and reviewing radiology request and developing recommendations to improve performance and suboptimal outcomes
- Promote and provide guidance to encourage practices that are based on best practice and are patient-centred.
- Use a behavioural change approach to influence human factors that lead to improved Choosing Wisely recommendations.
- Facilitate dissemination of information relating to Choosing Wisely.



- Participate and contribute to the ongoing delivery of Choosing Wisely related education.
- Provide guidance and support the removal of barriers preventing goals from being achieved.
- Ensure appropriate communication of activities and progress to relevant internal stakeholders.
- Identify, monitor and review project risks, recommending corrective actions and mitigations to manage risk.
- Work collaboratively to achieve project deliverables
- Become the champions for embedding Choosing Wisely change across Western Health

The impact on patient care and safety is always considered in discussions and decisions.

The members of this committee must adhere to Western Health's CARES Values, while always working to deliver 'Best Care' to our patients and community.

# **FREQUENCY OF MEETINGS**

The meetings will be held fortnightly initially and then monthly after the diagnostic phase is complete.

A quorum for a meeting will be a majority of the members, noting that in committees with an even number of members, this is half plus one. If at any time the number of members is less than a quorum, the committee may meet only for discussion purposes. The members of the committee will undertake their work in accordance with relevant Western Health policies, including the Values and Code of Conduct.

The agenda and minutes will be distributed to the members five days prior to the meeting.
